Lower-thirds, decorative text, animated logos, and graphics. [Avg. Lower-third graphics and text \$45 per incident (quarter day)]

Audio Repair - \$125/day

From original source audio, we remove hum, hiss, vehicle and airplane traffic noise, etc. [Avg. Low budget feature film noise removal \$62.50 per incident (half day)]

Surround Mix - \$125/day

Utilizing provided audio sources as well as our extensive bank of sound effects, we provide a 5-channel, surround sound audio mix for features and short films. [Avg. Low budget feature film \$500 (4 days)]

Color Correction - \$200/day

In keeping with the style, tone, and intended feel of the project, we provide rich temperature-matched color correction and grading. [Avg. Low budget feature film \$1,000 (5 days)]

TERMS & CONDITIONS

This Rate Card is to be considered an initial Quote. All rates listed are individually based with average (Avg.) project totals. Projects with multiple work Agreements will receive them at a discounted rate and Dogpile Productions will provide a Proposal, complete with scope of work, completion time estimates, and payment terms per information provided by Client.

Rates are subject to the following terms and conditions:

Payment schedule

Where the work is project based, the total amount quoted will be paid according to the following payment schedule:

25% Non-refundable deposit due upon signing of contract 25% due upon completion of production phase 50% due upon final completion and delivery of all media

Review process

The post-production phase shall be comprised of the following stages:

- 1. Scene Assembly (Client comments received)
- 2. First cut- (Client comments received)
- 3. Second cut (Client comments received)
- 4. Final cut- Client signs off project
- *Please note that additional revision stages will incur additional charges at the above rate.

Changes in specification

Should Client desire to make any changes or variations to any material or work in progress, and such changes result in additional labor or other costs, Dogpile Productions agrees to notify the Client of the amount before any such additional costs are incurred and work shall proceed only after receiving approval (written or oral) from Authorized Representative. Approval by Client shall be binding and incorporated into the terms of a prevailing Agreement. Reimbursement for such additional costs shall be payable in accordance with the terms of this Quotation for final payment.

Ownership

Except as otherwise provided herein, Client owns all rights, title and interest in and to the media(s) which are the subject of any prevailing Agreement, including all copyrights therein as well as all outtakes and other media provided by Client. Client grants Dogpile Productions an exclusive, worldwide, sublicenseable, transferable, royalty free license to all media clips produced during the course of the contracted work.

Payment

Client understands that the specified terms of payment under any prevailing Agreement are based upon timely payments due upon receipt of invoice. Ownership of the media does not transfer until payment is made in full.

Indemnification

Upon a prevailing Agreement, Dogpile Productions agrees to indemnify, defend, and hold harmless Client and its officers, employees, agents and licensees from and against any and all claims, actions, damages, liabilities and expenses, arising out of the breach of any obligation, warranty or representation of Dogpile Productions.

Upon a prevailing Agreement, contracting Client agrees to indemnify, defend, and hold harmless Dogpile Productions and its officers, employees, agents and licensees from and against any and all claims, actions, damages, liabilities and expenses, arising out of the reach of any obligation, warranty or representation of Contracting Client.

Tax liability

Any sales tax, use tax, or other tax payable on production and delivery of Specified Media(s) to Client(s) (other than sales tax arising from Dogpile Productions' purchases of materials or supplies in connection with the production) shall be the responsibility of Client who shall pay, defend and hold harmless Dogpile Productions from payment of any such taxes.

Shoot Cancellation & Postponement

If Client cancels or postpones a shoot more than 2 business days before the crew call time, Client may be eligible for a refund minus a \$350 service fee and any applicable bank or credit card charges.

If a client cancels or postpones a shoot within 2 business days of the crew call time, Client is responsible for paying 50% of the total cost of the shoot plus any applicable bank or credit card charges.

No refunds will be issued if a client cancels or postpones a shoot within 1 business day of the crew call time, except at the sole discretion of Dogpile Productions.

Client must provide written notification of any cancellations or postponements.

Project Cancellation & Postponement

If for any reason Client directs Dogpile Productions to stop work on a project, Client must provide written notification. Client agrees to pay for all services provided and costs incurred to date of written notice. In no case will the fee paid to Dogpile Productions be less than that of the deposit.
